About e-SHRAM Portal

- A National Database of Unorganized Workers (UWs)
- Technical Partner- NIC.
- Database authenticated with Aadhaar (97% coverage)
- Registration starting from 26th August, 2021
- 38 Crore unorganized workers will be registered on eSHRAM Portal.
- Coverage: Construction Workers, Migrant Workers, Street Vendors,
 Domestic Workers, Milkmen, Truck Drivers, Fishermen, Agriculture
 Workers, and similar other workers
- e-SHRAM card containing 12 digits UAN number
- Initially in English and Hindi

Major Objectives

Integration of **Social Security** Schemes e.g. PM-SYM, PMJJBY, PM-SBY, PMJAY **Sharing** of information with other Ministries/ Departments/ Boards/ Agencies/ Organizations of the Central & State Governments for delivery of various social security and welfare schemes being administered by them. Ascertaining the status and address/ current location of the migrant workers and also their movement from formal sector to informal sector and vice versa. **Portability** of welfare benefits to the migrant and construction workers on the lines of ONORC. Providing a comprehensive database to Central and State Governments for tackling any **National Crises** like COVID-19 in future.



Benefits of e-SHRAM Portal

- UAN on eSHRAM Card will be acceptable across the country
- Not required to register at multiple places.
- All registered UWs will be provided the Accidental Insurance Coverage of through PMSBY for a year.
- Rs 2 lakh for accidental death and permanent disability and Rs. 1 lakh for partial disability.
- Social security benefits of unorganized workers will be delivered through this portal.
- In case of any pandemic/ calamities like Covid-19, it will be helpful for State & Central Government to provide assistance to eligible UWs.

Role of Labour Unions

- Channelize labour unions/ workers' associations/ Federations/ civil society organisations working for the Unorganised Workers in the States and Districts to mobilise their workers for registration to nearest CSC.
- Help the State Authorities (in District level and State Level Committees) for creating awareness amongst the prospective beneficiaries and motivate them for registration
- All publicity material are available on <u>www.eshram.gov.in</u>. It can be downloaded and used for publicity.
- All labour union offices/ centres may put up pamphlets, posters, banners, help-desk tables in their offices for facilitating the workers.
- May organise Labour/ Workers Registration Camps.
