Accordingly, Dr.Rani Sadasiva Murty, Rashtriya Sanskrit Vidyapeetha has submitted the Mahabharata of Veda Vyasa in both Devanagari Script and Telugu Script each consisting of 8535 and 8568 pages respectively in 18 volumes each having nearly 1,00,000 slokas in each in printable mode having removed all the hyperlinks on 23.02.2018 and requested to relase an amount of Rs.1,96,920/- (Rupees One lakh Ninety Six thousand Nine hundred Twenty only) towards expenditure incurred for the above project.

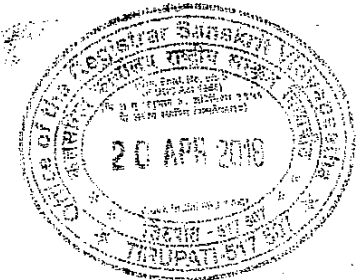

ESTABLISHMENT OF CHAIR ON SRI YOGI NAREYANA PHILOSOPHY AT THE RASHTRIYA SANSKRIT VIDYAPEETHA, TIRUPATI.

In continuation of the note submitted by the Vidyapeetha on 25.12.2014 and reply received from Gokula Foundation, Bangalore, the following is submitted for further consideration and approval by the foundation.

1. It is suggested by the Expert Committee of the R.S.Vidyapeetha, Tirupati to have 3 Project Fellows (instead of 2 as proposed earlier) to carry out the translation and research work in 3 languages viz., Sanskrit, English and Hindi.
2. It is also felt necessary to have an Office Asst. to support the ministerial work in the said project for which one Office Asst., may be considered for approval @ Rs. 6,000/- per month
3. Considering the above 2 revised proposals including enhancement in contingency amount of Rs. 10,000/- per month the Additional Project Fellow and one Office Assistant, the monthly expenditure on the part of the foundation would be as follows.

Asst. Professor-1	= Rs. 50,000/-
Project Fellows – 3	=Rs. 45,000/-
Computer Operator-1	= Rs. 15,000/-
Office Asst. -1	= Rs. 6,000/-
Attender -1	= Rs. 5,000/-
Contingencies	= Rs. 35,000/-

Total	= Rs.1,56,000/-
