For the position of Project Fellow : -01 Post - (UR)

Age: Preferably below 30 years

Essential:

A Master's Degree in Sanskrit Vyakarana (MA/Acharya) with proficiency in reading, speaking and writing in Sanskrit and English.

Desirable: Preference will be given to the Candidates with Master's Degree/Acharya in Vyakarana as the project is in Sanskrit Vyakarana

Engagement of eligible candidates for the above position is subject to following Terms and Conditions:-

- a. The above position is temporary and is initially for a period of one year and shall be renewed based on the performance and the candidate engaged shall have no claim for continued engagement in the Project or in the National Sanskrit University, Tirupati whatsoever. The University reserves the right to terminate the services of any of the Candidates so engaged, at any time during the engagement, without assigning any reasons.
- b. The Selections shall be based only on the performance in the Walk-in Interview.
- c. The University reserves the rights to:
 - a. fill up or not to fill up any of the vacancies advertised without assigning any reasons.
 - b. revise/re-schedule/cancel/suspend the recruitment process without assigning any reason. The decision of the University shall be final and no appeal shall be entertained.
 - c. reject any application without assigning any reason thereof.
 - d. relax the eligibility conditions in deserving cases.
- d. Canvassing will lead to forfeiture of the candidature.
- e. The applicants are advised to satisfy themselves before attending Walk-in-Interview that they fulfill the eligibility conditions as laid down for the positions in this notification. No enquiry seeking advice as to eligibility etc., will be entertained.
- f. The candidates shall attend the Walk-in- Interview at their own expenses. No TA/DA will be paid for attending the Interview.

- h. The candidate will not have any claim or entitlement of such benefits which are admissible to the regular employees of the University.
