05	Performance Bank Guarantee	<p>The Contractor is required to deposit an amount of Rs 5 Lakhs as security deposit in the form of Demand Draft drawn in favour of "Registrar, NSU Tirupati" with the University for the entire duration of the contract and also submit the Bank Guarantee equivalent of one month gross wage bill within 07 days from the date of signing the agreement, valid for 15 months from commencement of contract which will be renewed from time to time as per further renewals/amendment of the contract. Whenever the wage bill amount increases by 10% of the initial amount, additional Bank Guarantee shall be submitted by the contractor. Also, the Bank Guarantee shall be renewed by the Contractor from time to time if contract period is extended, which shall be valid for at least 03 months beyond the contract period.</p>
