TENDER NOTIFICATION


Sub: National Sanskrit University (NSU) - Hostels – Maintenance of Messes – Supply of Provisions - Invitation for Tenders – Regarding.

The NSU Hostels are running four Messes and one Guest House. Sealed Tenders are invited from the interested bidders in the field for supply of 'Provisions' **initially** for a period of **SIX** months w.e.f. **11.06.2026 to 10.12.2026** or until further orders whichever is earlier. The list of provisions is enclosed. The bids shall be submitted during office hours on all working days. The **last date and time for submission of bids is 04:00 PM on 05.06.2026**. NSU observes a five-day week (Monday to Friday). **The sealed tenders will be opened at 04:15 PM on 05.06.2026 in the presence of the bidders who are present at the time of opening.**

Terms & Conditions:

1. The duration of the Rate Contract is 6 months initially;
2. The bidder shall submit the Tender in a sealed cover super scribing as "**Tender for Supply of Provisions**";
3. The bid should be dropped personally in the Tender Box available in the Office of the Registrar during office hours on all working days;
4. Incomplete, Unsigned, Conditional and Late bids will be rejected;
5. The supplier shall quote the best and competitive prices;
6. Supplier shall quote for all the items in the list, otherwise the bid will be rejected;
7. Wherever names of specific brands are mentioned for some items in the list, the bidder shall quote for all those brands, otherwise the Tender is considered as incomplete and rejected;
8. The items listed from S.No. 01 to 30 are considered as "Main Items" with high consumption and the bidder who has quoted overall Lowest price for these "Main Items" only will be awarded the Rate Contract;
9. Bids containing abnormally high/ low and unrealistic prices in respect of any of the items in the list shall be summarily rejected;
10. The bidders shall affix proper seal of the company and signature of the authorised person;
11. The bidder who is awarded the Contract should supply the Provisions to the hostels & Guest House at his own expense and risk;
12. Net weight only will be considered for payment;
13. Wastage and damage of the Provisions should be replaced by the bidder within 24 hrs;
14. The Registrar is entitled to extend/cancel the Contract partially/ fully with due justification;
15. Self-Certified photocopies of Registration of the Firm, PAN & GSTIN in the name of the shop/firm, are to be enclosed to the Bid, **without which the Tender shall not be considered;**
16. The items supplied should be of good quality and ready to use;

17. The bidder should have a registered firm in Tirupati;
18. The Rate Contract should not be sub-leased to anyone in any manner. Any complaints in this regard would result in cancellation of the Contract;
19. **The Contractor should send the bill along with the material clearly indicating the name of each item with weight/quantity of units, as the case may be;**
20. **The Contractor should submit a consolidated bill on the last day of every month. No part-payment or advance payment will be made under any circumstances. The payment will be made by 15th of the following month by Online/Cheque;**
21. Statutory deductions at applicable rates will be made from payments due to the supplier. TDS Certificate will be issued by NSU at the end of the financial year;
22. The bidders are advised to be conversant with the terms & conditions as stated above before submitting the bid;
23. Considering this Contract as "Contract for essential items", NSU reserves the right to enter into Parallel Contracts for the same item at the same rate. For this purpose, NSU may issue Counter Offers to L2, L3, etc. to supply the items at L1 rates;
24. **Fall Clause:-** In case, if the Contractor supplies the items as specified in this Contract at the lowest price to any other party, during the period of Contract, that lowest price will be applicable to this Contract also;
25. **Risk Purchase:-** If the Contractor fails to supply the requisite quantity/quality of the material, NSU is at liberty to purchase such items from the local market to meet their requirements and claim the difference in price on higher side from the Contractor / deduct from the bills on hand;
26. There should not be any correction/overwriting in the bid;
27. NSU provides breakfast, lunch and dinner daily approx. 1300 students. Whenever there is a vacation to the students on account of Dasara, Sankranti and summer holidays, the requirement will be reduced to zero and the Contractor will be informed in advance about the vacation;
28. The prices mentioned in the Contract are firm and fixed and no request for increase of price will be entertained during the period of the Rate Contract;
29. The prices quoted by the bidder shall be inclusive of all taxes and duties;
30. **"Bidders shall fill the price column alone"** in the enclosed Annexure-1 and affix the seal of the Firm/Agency/Co. with signature and date and put in a cover and seal it. Bids without signature and seal, will be rejected.
31. The bidder shall clearly superscribe on the sealed cover as **"Bid for Provisions against Tender No: NSU/Hostel/Prov./2026-27/001"**.
32. The quantity mentioned in the price bid format is a monthly estimate to calculate the bid value. The University does not guarantee that this estimated monthly consumption will be maintained.
33. In case of any dispute between NSU and the Contractor, the decision of the Registrar is final and binding on both the parties;
34. NSU reserves the right to delete any items from the list while finalising the Rate Contract.
35. **The bills have to be consolidated based on GST incurred (Eg. 5% -bill, 12%- bill, 18%-bill etc.,) and submitted separately.**


