ELIGIBILITY CONDITIONS:

Essential Qualification

A.

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Byelaws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminarsponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such master's Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

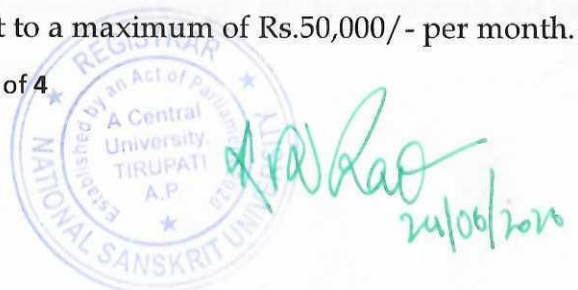
- B. The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (AR WU) of the Shanghai Jiao Tong University (Shanghai).

DESIRABLE:

1. Candidate must have the ability to teach in Sanskrit language for the subjects concerned.
2. B.Ed. / Siksha Sastri in Sanskrit.

HONORARIUM:

Fixed honorarium of Rs.1500/- per lecture subject to a maximum of Rs.50,000/- per month.



GENERAL INFORMATION

1. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non- creamy Layer)/ Differently-abled (a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible. based only on the qualifying marks Without including any grace mark procedure.

2. The selections shall be based only on the performance in the interview.
3. The University reserves right to increase/ decrease or cancel any post/notification without assigning reasons thereon.
4. If any claim/certificate/ document is found to be false/fake/incorrect at any stage of verification before or after engagement, necessary action will be initiated against the candidate and the candidature shall be cancelled and engagement shall be terminated forthwith if engaged.
5. The University reserves the right:
 - a. to fill up or not to fill up any of the vacancies advertised without assigning any reasons.
 - b. to revise/re-schedule/cancel/suspend the recruitment process without assigning any reason. The decision of the University shall be final, and no appeal shall be entertained.
 - c. to reject any application without assigning any reason thereof.
 - d. to relax the eligibility conditions in deserving cases.
6. Canvassing will lead to debarring the candidatures.
7. The applicants are advised to satisfy themselves before attending Walk-in-Interview that they fulfill the eligibility conditions as laid down for the positions in this notification. No enquiry seeking advice as to eligibility etc., will not be entertained.
8. Candidates belonging to OBC category but coming under creamy layer will not be entitled to the benefits of reservation and should apply under UR category.



9. Caste Certificate issued by Officer who is not below the rank of Mandal Revenue Officer/Tahsildar concerned in respect of SC/ST/OBC candidates shall be submitted at the time of Walk-in Interview.
10. The candidates shall attend the Walk-in-Interview at their own expenses.
11. All the candidates are hereby requested to be present at 9:00 Hrs. for the Morning session and 13:00 Hrs. for the Afternoon session for verification of testimonials. All the candidates should carry their Biodata, Original Certificates and Caste Certificate (wherever applicable). Further, they are requested to submit a copy of the same at the time of verification. They shall not be permitted for the interviews reporting after 10:00 A.M. and 2:00 P.M. for Morning and Afternoon Sessions respectively.
12. **The candidates must submit a Demand Draft / Banker's Cheque for Rs.500/- (Rupees Five Hundred only) drawn in favour of The Registrar, National Sanskrit University, Tirupati, payable at Tirupati towards registration fee/processing fee at the time of verification.**
13. The engagement of Guest Faculty is purely temporary.

15. Jurisdiction: In case of any disputes, the territorial jurisdiction for adjudication shall be the Hon'ble High Court of Andhra Pradesh only.

 - a. The engagement of Guest Faculty is purely temporary and will not have any claim over regularization. The engagement is purely for the Academic year 2026-27.
 - b. The engagement is co-terminus with the closing of the Academic year 2026-27. The University reserves the right to terminate the services of Guest Faculty without assigning any reasons therefor even before the expiry of term as stipulated.
 - c. Guest Faculty will not have any claim or entitlement of such benefits which are admissible to the regular employees of the University.
 - d. Guest Faculty shall abide by all other conditions/rules of National Sanskrit University, Tirupati in force and changes if any thereon from time to time.
 - e. The Guest Faculty shall not deny any assignment given by Head, Concerned Departments, Dean of the Schools of Study, Dean, Academic Affairs and Registrar viz. taking extra classes, on line classes, examination duties, etc., as per the requirement.
 - f. The honorarium payable is subject to TDS under the Income Tax Act, 1961 and other relevant provisions in force, as applicable.
