The students are directed to make readily available all original Certificates viz. 10th/SSC Certificate, +2 / Prak Sastri Certificate, Shastri Certificate valid Community Certificate in the prescribed proforma (especially OBC-Non Creamy Layer & EWS candidates), Transfer Certificate, Conduct Certificate, including the ones as detailed in the "Status / Remarks" Column of the Select List etc. as detailed in the Prospectus for verification and submission.
6. In case any candidates fail to remit the Programme Fee and consequently, any seats remain unfilled with the Select List candidates latest by 23-11-2022 or due to cancellation or for whatever other reason, the candidates under the Waiting List shall be considered for admission.
