Subject: Instruction for Preparation and Implementation of Cyber Crisis Management Plan (CCMP) for countering Cyber-Attacks and Cyber Terrorism in Central Government Ministries/ Departments and States/ UTs-reg.

Please refer to this Ministry's Note of even No. dated 05.08.2022 on the subject mentioned above.

2. In this regard, it is reiterated that MeitY has prepared National Cyber Crisis Management Plan (N-CCMP) as per the directions of the National Crisis Management Committee (NCMC), Indian Computer Emergency Response Team (CERT-In) to counter cyber attacks and cyber terrorism which is reviewed periodically at Cabinet Secretariat.
3. The purpose of this plan is to establish the strategic framework and actions to prepare for, respond to, and begin to coordinate recovery from cyber incidents. The plan has enumerated guidelines for entities for building cyber resilience, planning and preparation for incident handling and recovery therefrom.
4. Further, CERT-In has been providing necessary enabling assistance to Central Govt. Ministries/Departments and States/UTs in preparing and implementing their own sectoral/state CCMP.
5. Director/ Vice Chancellor of All Higher Education Institution (including Central Universities, IIMs, IISc Bangalore & IISERs, IITs, IIITs, Institutions of National Importance, NITs NITTTRs) under D/o Higher Education are hereby requested to take the necessary actions on below mentioned points:
 - i. To appoint a Chief Information Security Officer CISO at their Organisation/institution
 - ii. To implement the guidelines contained in the CCMP and prepare their own Sectoral and Organizational Cyber security plans in line with the N-CCMP.
 - iii. To check cyber security measures taken so far.
 - iv. To get a survey done of all the computers viz. PCs, laptops etc. being used in their organisation/institution for any pirated softwares or obsolete softwares.
 - v. To inform the current Status of CCMP.
6. This issues with the approval of the Competent Authority.
