2. Measures taken to complete the syllabus of courses and progr	ams.	The Center of Distance and Online Education has taken various steps to complete the courses. After the admission of students, CDOE sends study materials to the address given by the student. The students study the Self Learning Materials before attending the contact classes. CDOE conducts contact classes for the enrolled students. The contact classes are held twice a year for at least fifteen days. Students come to the CDOE of National Sanskrit University, Tirupati. Here University arranges food and accommodation facilities for the students. Students stay in the Hostel/Guest house for 15 days and attend the contact classes regularly. Every day 4 classes have conducted. University professors and eminent scholars from pan India take the contact classes. The students are provided with face to face teaching facilities. The student teacher interaction of CDOE is very effective. The syllabus is covered in a very simple. Question and answer method is used for better understanding with the students. In this process students use the Central library of the University and CDOE library. Professors also provide notes to the students.
