About Odisha Chair (A Study centre for Lord Jagannatha, Mahaprabhu Chaitanya and Bhaktakavi Jayadeva)

The Government of Odisha has established the Odisha Chair in the University to do intensive and extensive research, to bring out publications on Lord Jagannatha and to highlight the contributions made by Sri Chaitanya Mahaprabhu and poet Sri Jayadeva to the cultural heritage of our country. The Chair was formally inaugurated by Justice Sri Ranganath Misra, Former Chief Justice of India and Chairman, Central Sanskrit Board, Government of India on 14th October, 2000.

The Odishaa Chair was established under Rashtriya Sanskrit Vidyapeetha, (Deemed University) now National Sanskrit University, , Tirupati, on behalf of the Government of Odishsa, with the aims of carrying out intensive and extensive research work and to bring out Publications on three important aspects of not only the culture of Odisha but also of India viz Lord Sri Jagannatha Dharma and his Cult, Sri Chaitanya and his Philosophy, and Sri Jayadeva and his Literature. Odisha Chair was established in this University with the munificent grant sanctioned by the Government of Odisha. The then Chief Minister was kind enough to institute a chair in this university to carry out research and extension activities on Shri Jagannatha Culture, Shri Jayadeva Literature, Shri Chaitanya Philosophy. Prof. S.B.Raghunatha Acharya the then Vice-Chancellor of the Vidyapeetha was instrumental in pursuing the Odisha Govt. in establishing the Chair. Late Prof. Ramaranjan Mukherji, Former Chancellor of Our Vidyapeetha and Prof Harekrishna Satapathy the then Vice-Chancellor of SJSV Puri and the then Vice-Chancellor of our University played a key role in getting the Chair established.

The Chair was formally inaugurated in the year 2000. Justice Sri Ranganatha Mishra, Chairman ,Central Board of Sanskrit Education Govt. of India has inaugurated the Chair on 15th October,2000. Justice Sri Ranganatha Mishra speaking on the occasion observed that the Vidyapeetha is the right institution for caring out research on the subject. Prof. Harekrishna Satapthy the then Vice-Chancellor of Shri Jagannatha Sanskrit University delivered the inaugural address on the occasion.

THE SOURCE

Chaitanya Mahaprabhu was spiritual leader who founded Gaudiya Vaishnavism during 15th century. He is believed by his devotees to be Krishna

Himself who appeared in the form of his own devotee in order to teach the people of the World the process of Bhakti and how to attain the perfection in life. He was the proponent the Vaishnava school of Bhakti Yoga based on Bhagabata puran and Bhagabat Gita and popularised Hare Krishna mantra and composed the Sikshystakam (Eight devotional Prayers) in Sanskrit.

Despite having been initiated in the Madhavacharya tradition and taking Sanyasa from sankar;s tradition, Chaitanyas philosophy is sometimes regarded as a tradition of his own within Vaishnava framework. He took Mantra Upadesha from Iswara Puri and sanyasa diksha from Kesab Bharati.

Chaitanya is known to have written anything himself expect for a series of verses known as Sikshystak"eight verses of instruction ". The eight verses created by Chaitanya are considered to contain the complete philosophy of Gaudiya Vaishnavism.
