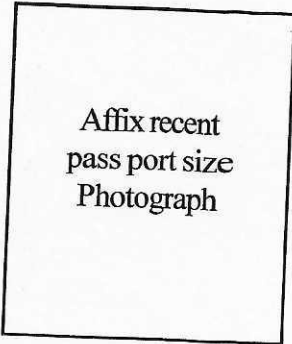


ATTESTATION FORM
