In this context, it is to be noted that in terms of Ashtaadashi Guidelines, as first instalment 50% of the sanctioned Grants-in-Aid i.e. Rs. 7,50,000/- (seven lakh fifty thousand only) has already been electronically transferred to your Institutional bank Account on 28.03.2023 (copy enclosed).
